### INFORMATION AND RULES:

Event will take place rain or shine. Check in starts at 8:00 am. Last ride out: 10:30 am. Ride is approximately six miles of easy to technical difficulty on clearly marked trails. Prize winners must be present to win. Junior riders are required to wear a helmet during the ride and for safety, adults are encouraged to do the same. No stallions. No pets on ride. No riding double. No riding in picnic areas or beaches. All State Park rules apply, including No Alcohol. All poker card envelopes must remain sealed and turned in by 2:00 PM to be counted. Entries received day of ride will not be guaranteed a goodie eco-bag. All riders entering online or by mail must agree to the Liability and Photography Release. Any junior rider must have parental consent form and if without parent be with the adult listed on consent form. Ride participation and final card turn in time at the discretion of the Ride Manager.

# 1. RELEASE FROM ALL LIABILITY

**This is a binding legal document. Read it carefully before signing below.**

I understand that the **California Conservation of Trails** sponsors and organizes a variety of events, including, but not limited to, equestrian trail rides and overnight campouts, trail building and work days, tack sales, membership meetings, potluck dinners, and other social events. **California Conservation of Trails** events are non-alcoholic. In consideration of the acceptance of my application or permission to participate in these events, I agree to defend, indemnify, and hold harmless the Folsom Lake SRA Mounted Trail Patrol and/or California State Parks and/or **California Conservation of Trails**, its officers, members, agents, employees, and representatives, from and against all claims, suits, actions, or liabilities (including any of the foregoing by way of indemnification or contribution), for personal injuries, property damage or loss, death, or for attorney fees, which are based on or arise out of my participation in such events. This release applies to all such claims, suits, actions, or liabilities, even though they may arise out of or be based on the negligence, lack of care, or other fault on the part of the persons listed above.

In signing this release I acknowledge that (a) equestrian events and activities involving horses involve risks which may result in serious personal injuries, property damage or loss, or death, (b) that trails and areas for equestrian events may consist of rough trails, steep or unstable terrain, water hazards, wild animals, and other natural or man made obstacles and dangers, and that I may expect to encounter such areas in their natural condition without any preparation or safeguards designed for equestrian activities, and (c) that horses themselves may create dangers because of kicking, running away, throwing riders off, and other disruptive and uncontrollable behaviors.

I am sufficiently skilled in riding horses, and am sufficiently physically fit, to participate in the equestrian events listed above. **This release is binding on my heirs, executors, administrators, and personal representatives.**
